## 1 Introduction

I am pleased to inform you that the third annual general meeting (“**AGM**”) of Taylor Maritime Investments Limited (the “**Company**”) will be held at 09.30 a.m. on 4 September 2024 at Level 5 St Julian’s Court, St Julian’s Avenue, Saint Peter Port, Guernsey, GY1 1WA (the “**AGM**”). The notice of the AGM is set out on pages 3 and 4 of this document.

In addition to the ordinary business of the AGM, resolutions are being proposed to authorise the Company to buy back its own Ordinary Shares and to authorise the Company to issue further Ordinary Shares. Details of the ordinary and special business to be proposed at the AGM are set out in the attached notice, and in the explanatory notes on pages 4 and 5 of this document. All holders of Ordinary Shares are entitled to attend and vote at the AGM.

## 2 Action to be taken

Shareholders will find enclosed with this document a Form of Proxy for use at the AGM.

Shareholders are asked to complete and return the Form of Proxy in accordance with the instructions printed thereon to the Company’s Registrar, Computershare, or deliver it by hand during office hours only to the same address so as to be received as soon as possible and in any event by no later than 09.30 a.m. on 2 September 2024.

Shareholders are welcome to attend the AGM in person or to complete and return the enclosed Form of Proxy in accordance with the instructions printed thereon and in this document. Shareholders are strongly urged to appoint the Chairman of the AGM as their proxy to vote on their behalf. If you appoint someone else (other than the Chairman of the AGM) to be your proxy, this may result in your vote not being counted if your proxy is unable to attend the AGM. ## ORDINARY BUSINESS

## SPECIAL BUSINESS

To consider and, if thought fit, pass the following resolutions which will be proposed as extraordinary resolutions:

14. THAT the Company be and is hereby generally and unconditionally authorised in accordance with Section 315 of The Companies (Guernsey) Law, 2008 (as amended) (the "**Law**") to make market acquisitions (as defined in the Law) of its ordinary shares of no par value in the capital of the Company ("**Ordinary Shares**"), provided that:
  - a. the maximum aggregate number of Ordinary Shares hereby authorised to be purchased is such number as represents 14.99% of the Ordinary Shares in issue immediately following the passing of this resolution;
  - b. the minimum price (exclusive of expenses) which may be paid for an Ordinary Share is 1 US\$ cent;
  - c. the maximum price (exclusive of expenses) which may be paid for an Ordinary Share shall be not more than the higher of (i) 5% above the average market value of an Ordinary Share for the five business days prior to the day the purchase is made and (ii) the value of an Ordinary Share calculated on the basis of the higher of the price quoted for the last independent trade and the highest independent bid for any number of the Ordinary Shares on the trading venue where the purchase is carried out;
  - d. the authority hereby conferred shall expire at the conclusion of the next annual general meeting of the Company held in 2025 or 15 months from the date of this resolution, whichever is the earlier, unless such authority is varied, revoked or renewed prior to such time; and
  - e. the Company may make a contract to purchase Ordinary Shares under the authority hereby conferred prior to the expiry of such authority which will or may be executed wholly or partly after the expiration of such authority and may make an acquisition of Ordinary Shares pursuant to any such contract.

15. THAT the Directors of the Company be and are hereby empowered to issue the following shares in the Company or rights to subscribe for such shares in the Company for cash as if the pre-emption provisions contained under Article 9 of the Company's articles of incorporation did not apply to any such issues provided that this power shall be limited to the issue of the below-mentioned shares or of rights to subscribe for the below-mentioned shares:

(i) up to a maximum number of 33 million Ordinary Shares;

# Explanatory Notes

## Resolutions 4 to 10: Election of Directors

Resolutions 4 to 10, which are ordinary resolutions, propose the election or re-election of each of the Directors of the Company in accordance with the Association of Investment Companies (the “AIC”) Code of Corporate Governance (the “AIC Code”). Charles Maltby was appointed to the Board by the Directors in the period following the 2023 AGM, therefore, pursuant to Article 25.2, is standing for election by Shareholders.

As explained in the Chairman’s Statement of the annual report and audited consolidated financial statements for the year ending 31 March 2024 (the “Annual Report”), as part of the Board’s integration strategy Mr. Chris Buttery and Mr. Frank Dunne have each agreed that they will not stand for re-election by shareholders and will retire at the 2024 AGM and, following a thorough vetting process led by the Nomination & Remuneration Committee, that Ms. Rebecca Brosnan and Mr. Gordon French (each an existing Director of Grindrod Shipping Holdings Limited (“Grindrod”)) will be recommended for election by Shareholders at the 2024 AGM to succeed the two retiring Directors.

Having reviewed the performance of the Board and the leadership needs of the Company, the Board believes that each of the existing Directors seeking re-election should continue in their role as they bring a breadth of current and relevant business expertise to the Board. The Board remains satisfied that the individual contributions of each of the current Directors are, and would continue to be, important to the Company’s long-term sustainable success. Biographical details for each of the current Directors standing for election and details of their individual contributions to the operation of the Board during the year are contained in the Annual Report. Biographical details for the recommended appointees from the Grindrod Board are set out below:

### Rebecca Brosnan

Ms. Brosnan has over 20 years’ experience in investment banking, financial markets and commodities and is currently an IFC nominated director of City Bank, a listed commercial bank in Bangladesh. She previously served as CFO and Head of Strategy of Diginex, an ESG and sustainability business and as Head of Asia Commodities and Head of Strategy at the Hong Kong Stock Exchange. She was appointed as a non-executive Director of Grindrod in 2022. Ms. Brosnan graduated Trinity College with a BA in Economics, holds an MA from the London School of Economics in History of International Relations, and has completed the Harvard Business School’s General Management Program.

### Gordon French

Mr. French has extensive experience in investment banking, having worked for the HSBC group for 33 years and on his retirement in 2020 he was Head of Global Banking and Markets for Asia-Pacific, based in Hong Kong, with responsibility for all global banking, markets,

securities services, global liquidity and cash management in the region. He was appointed a non-executive Director of Grindrod in 2023. Mr. French holds a Bachelor of Commerce degree from the University of Melbourne.

## Resolutions 11 and 12: Re-appointment and remuneration of the auditors

As explained in the Annual Report, the Group undertook an audit tender exercise during 2023 and, following a rigorous external audit tender process and a comprehensive evaluation of the prospective firms by an audit tender panel including representation of key stakeholders from both the Company and Grindrod, PricewaterhouseCoopers CI LLP stood down and were succeeded by Deloitte LLP as external auditor on 6 December 2023. Accordingly, the Directors are recommending the re-appointment of Deloitte LLP as external auditor.

## Resolution 13: Approval of dividend policy

Under the Articles, the Board is authorised to approve the payment of interim dividends without the need for the prior approval of the Company’s shareholders. Having regard to corporate governance best practice relating to the payment of interim dividends, the Board has decided to seek express approval from shareholders of its dividend policy which is to pay four interim dividends per year.

## Resolution 14: Market acquisitions

This resolution gives the Company authority to make market acquisitions of the Company’s own Ordinary Shares, up to a maximum of 14.99% per annum of the Company’s Ordinary Shares in issue (as at the time immediately following the passing of the resolution) and subject to minimum and maximum purchase prices as set out in parts b. and c. of resolution 14. This authority will only be invoked if, after taking proper advice, the Directors consider that benefits will accrue to shareholders generally.

The Board intends only to make purchases of the Company’s own Ordinary Shares in circumstances where doing so would be accretive to existing shareholders. The Board recognises their duty under the AIC Code to monitor the Company’s share price and to take action to address discounts to NAV. The Board only intends to undertake purchases after careful consideration and in consultation with advisers to ensure that doing so would benefit long-term shareholders.

## Resolution 15: Authority to issue Ordinary Shares and Disapplication of pre-emption under the Articles

This resolution is a standard resolution for investment companies listed under Chapter 15 of the UK Listing Rules and

provides for the authority to the Directors to allot Ordinary Shares for cash without first offering them to existing holders on a pro rata basis. Resolution 15 provides authority to allot up to 10% (33 million) of the number of Ordinary Shares in issue immediately following the passing of this resolution. The Directors only intend to use the authority to issue Ordinary Shares pursuant to the authority granted by resolution 15 to take advantage of market opportunities as they arise and if they believe it would be advantageous to the Company's shareholders to do so.

## Notes to the Notice of AGM

1. A shareholder is entitled to appoint another person as his proxy to exercise all or any of his rights to attend and to speak and vote at the AGM. A shareholder may appoint more than one proxy in relation to the AGM provided that each proxy is appointed to exercise the rights attached to a different share or shares held by that shareholder. A proxy need not also be a shareholder of the Company.
2. Shareholders will find enclosed a form of proxy for use in connection with the AGM (and any adjournment). The form of proxy should be completed in accordance with the instructions. To be valid, the form of proxy (together with the power of attorney or other authority, if any, under which it is executed or a notarially certified copy of such power or authority) must be deposited at the offices of the Company's registrars at the following address:

Where a form of proxy is given by email the power of attorney or other authority, if any, under which it is executed or a notarially certified copy of such power or authority must be deposited at the offices of the Company's Registrars at the above address by the appointed time. A space has been included in the form of proxy to allow shareholders to specify the number of shares in respect of which that proxy is appointed. Shareholders who return the form of proxy duly executed but leave this space blank will be deemed to have appointed the proxy in respect of all of their shares. 4. In the case of joint holders, any one holder may vote. If more than one holder is present at the meeting, only the vote of the senior will be accepted, seniority being determined in the order in which the names appear on the register of shareholders of the Company.

5. The quorum for the AGM shall be two or more members present in person or by proxy and holding 5% or more of the voting rights available at such meeting. To allow effective constitution of the meeting, if it is apparent to the chair that no shareholders will be present in person or by proxy, other than by proxy in the chair's favour, then the chair may appoint a substitute to act as proxy in his stead for any shareholder, provided that such substitute proxy shall vote on the same basis as the chair.
6. The total issued share capital of the Company as at the date of this Notice of AGM is 330,215,878 Ordinary Shares. Pursuant to the Articles, on a show of hands every member (being an individual) present in person or by proxy or (being a corporation) present by a duly authorised representative shall have one vote on a show of hands, and one vote per Ordinary Share on a poll (other than the Company itself where it holds its own shares as treasury shares). As at the date of this Notice of AGM, there are no outstanding warrants and/or options to subscribe for Ordinary Shares and there are no treasury shares in issue.
7. An ordinary resolution of the members (or of a class of members) of the Company means a resolution passed by a simple majority.
8. A special resolution of the members (or of a class of members) of the Company means a resolution passed by a majority of not less than 75%.
9. An extraordinary resolution of the members (or of a class of members) of the Company means a resolution passed by a majority of not less than 75%.
10. A corporate shareholder may by resolution of its board or other governing body, authorise such person or persons as it thinks fit to act as its representative at the AGM. Where a person is authorised to represent a corporate shareholder, he may be required to produce a certified copy of the resolution from which he derives his authority.
11. To be entitled to attend and vote at the AGM (and for the purpose of the determination by the Company of the votes they may cast), shareholders must be registered in the register of members of the Company at 6.00 p.m. on 2 September 2024 or, in the event of any adjournment, at 6.00 p.m. on the date which is two days before the time of the adjourned meeting. Changes to entries on the register of shareholders after the relevant deadline shall be disregarded in determining the rights of any person to attend and vote at the AGM.
12. CREST members who wish to appoint a proxy or proxies by utilising the CREST electronic proxy appointment service may do so for the AGM (and any adjournments thereof) by utilising the procedures described in the CREST manual (the "**CREST Manual**"). CREST personal members or other CREST sponsored members, and those CREST members who have appointed a voting service provider(s) should refer to their CREST sponsor or voting service providers, who will be able to take the appropriate action on their behalf.
13. In order for a proxy appointment made by means of CREST to be valid, the appropriate CREST message (a "**CREST Proxy Instruction**") must be properly authenticated in accordance with Euroclear UK & Ireland Limited's specifications and must contain the information required for such instructions, as described in the CREST Manual. The message must be transmitted so as to be received by the Registrar, by the latest time for receipt of proxy appointments specified in this notice of AGM. For this

purpose, the time of receipt will be taken to be the time (as determined by the timestamp applied to the message by the CREST Applications Host) from which the issuer's agent is able to retrieve the message by enquiry to CREST in the manner prescribed by CREST.

14. CREST members and, where applicable, their CREST sponsors or voting service providers should note that Euroclear UK & Ireland Limited does not make available special procedures in CREST for any particular messages. Normal system timings and limitations will therefore apply in relation to the input of CREST Proxy Instructions. It is the responsibility of the CREST member concerned to take (or, if the CREST member is a CREST personal member or sponsored member or has appointed a voting service provider, to procure that his CREST sponsor or voting service provider takes) such action as shall be necessary to ensure that a message is transmitted by means of the CREST system by any particular time. In this connection, CREST members and, where applicable, their CREST sponsors or voting service providers are referred, in particular, to those sections of the CREST Manual concerning limitations of the CREST system and timings. The Company may treat as invalid a CREST Proxy Instruction in the circumstances set out in Regulation 34 of the Uncertificated Securities (Guernsey) Regulations 2009.
